We will assess the following fees to cancellations received via e-mail between May 5 and May 22: Conference \$325; Pre/Post-Conference Courses \$100/course. After May 22, no refunds will be issued. In addition, no refunds will be issued for any missed sessions or events (luncheons, etc.), including sessions or events missed due to travel delays or cancellations.
